The Barb Elliott Trust Fund is a fund that is available for diaconal projects that are innovative and difficult to fund. This fund is still relatively new and needs ongoing donations to build its capital in order to provide a substantial amount of available interest.

This is a school that Betty Marlin worked with while she was in Zambia.
