Report of the First Conference of the Deaconesses of the United Church of Canada

Time-March 2 and 3, 1926.

Place—Morning and Afternoon Sessions at the National Training School, 135 St. Clair Ave. W.

Evening Sessions, 60 Grosvenor St.

Chairmen—Tuesday—Miss Hall. Wednesday—Miss Wilcox.

Devotional Study—General Theme—"How Jesus Faced Life's Questions."

Study 1.—Jesus' Definition of Ideals, led by Dr. Rich. Davidson.

I find something of what God is like if I look into the face of nature; more if I look into the face of my hrother man; most if I look upon the Word made Flesh, brother of all men, friend of the poor, feeder of the hungry, healer of the sick. Jesus didn't define His ideals, He lived them, and they are forever luminous.

Study 2.—How Far Should Custom Determine Our Standards of Conduct, led by Rev. A. L. Richards.

- 1. Give custom an honored place.
- Give custom an honored place only so far as it is not contrary to the mind of Jesus.
- Custom must give place on great issues, sectarianism, prohibition, war, the industrial order.

4. The test of any custom is, "Does it unify life; does it enrich life?"

Study 3.—The Duty of Interpreting the Thought of our Times, led by Rev. Chas. Bishop.

There are three things necessary:

1. An historical perspective.

- 2. The power to discriminate between the new and the old, movements which are dying and those which will live.
- 3. A looking to the future-work with the young or in line with the thought of the young.

This ability is a reflex from the ability our Lord had, who, in laying down His life, assured the future of the Kingdom.

Study 4.—How Jesus Faced Life's Questions, led by Dr. J. C. Robertson.

The chief address of the Conference was given by Rev. Peter Bryce on "The Evolution of Deaconess Work."

1. The evolution from supplying the poor family with clothing to that of the trained social worker whose task is the constructive rehabilitation of the family.
2. The evolution from supervizing a

nursery to the leadership in Religious Edu-

cation.

The Conference was marked throughout by real fellowship and the spirit of "each preferring the other in love"; and the two days passed all too quickly. Many old friendships were renewed and new ones formed, and it is with gratitude that we look back upon our Conference and with expectation to the future.

The Report of the Findings Committee.

1. Re the duties of the Deaconess. While it is recognized that the work of the Deaconess in most situations must be of a general character; Resolved, that in the best interests of the worker and of the church she serves, the energies of the Deaconess should not be dissipated in too many forms of service; that at least major importance should be given, by preliminary agreement and understanding, to the form of work that constitutes the greatest need in the local church; that such an understanding involves a responsibility not only to the Church and the Deaconess, but to whatever Board is charged with supervision of Deaconess Work.

2. In view of developments that are progressively taking place in Deaconess Work, and the increased demands for scientific training in Social Service and Religious Education; Resolved, that standards of entrance must be fixed ever with an eye to the future, not to the past.

3. Re the Method of Appointment.

Resolved, that the method of appointment be through a Committee of the General Council which shall keep in close touch with each Deaconess and make an earnest effort to secure positions for all Deaconesses—recommending the Deaconess to a position and confirming appointments, but leaving the Church or Board to make its own arrangement with the worker, subject to regulations approved by the General Council of the Church.

Resolved, that there should be representatives from the Deaconess Body on the General Council's Committee thus charged with

supervision of Deaconess Work.

4. Re Salary; Resolved, that the minimum should be \$1,000 per annum, increasing with experience to \$1,200 or to \$1,500.

Re Superannuation; Resolved, that the hope of the Deaconess' Association is that

provision shall be made for Superannuation of members of the Order through whatever Board of the General Council has responsibility for Superannuation of Ministers of the Church.

5. Re Uniform and Pin; Resolved, that it is in the best interests of the work that a uniform he approved, which Deaconesses shall have the privilege of wearing according to their discretion.

6. Re Deaconess Homes; Resolved, that

to the Church that the present system of the Church that the present system of residence in Deaconess Homes be not per-

netwated

7. Re Probation; Resolved, that while time has not been sufficient for the consideration of all the implications of a one, and two-year period between graduation and being designated to the Deaconess Order, that this Conference commend this question to the careful, and sympathetic consideration of the Deaconess Board.

Recommendations of the Executive, endorsed by the Conference.

 Re Name of Association, the name shall be The Deaconess Association of the United Church of Canada.

Re Membership. All Deaconesses in active service are eligible.

3. Time of Meeting. (Referred to the new executive.

4. The membership fee shall be \$1.

It was agreed that in addition to the formation of the Deaconess Association of the United Church of Canada, to be comprised

of Deaconesses in active service, there shall be formed or continued an Alumnae Association, which shall be comprised of all graduates of the Training School or Schools.
